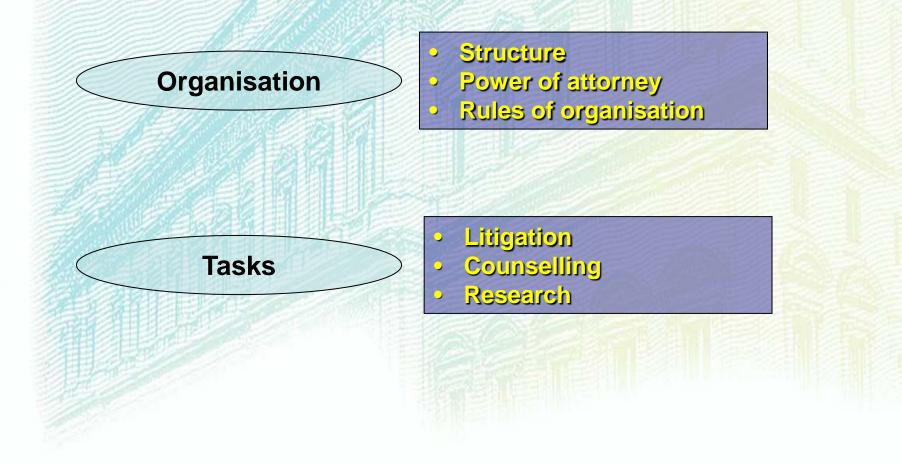

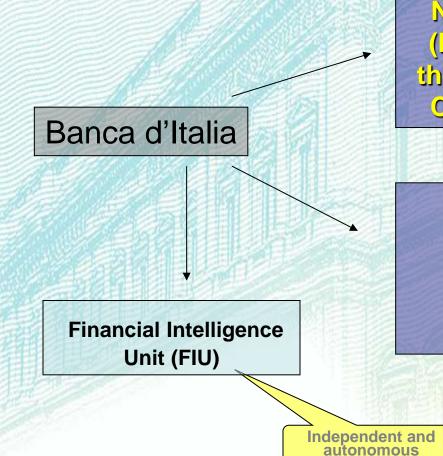

An overview of the «client» Task and Functions of Banca d'Italia

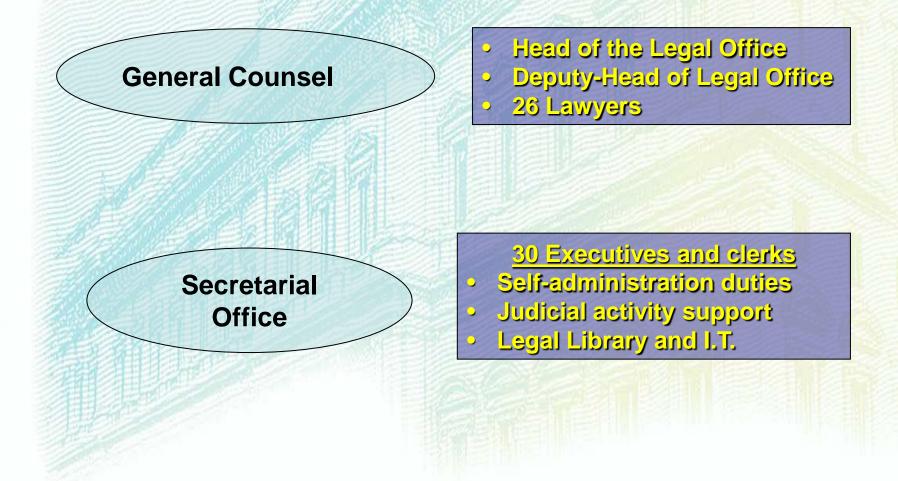


National Central Bank (NCB) partecipating in the European System of Central Banks (ESCB)

Organisation The legal status of the lawyers

Only lawyers admitted to the Bar ("Avvocato") can represent a client before a Court

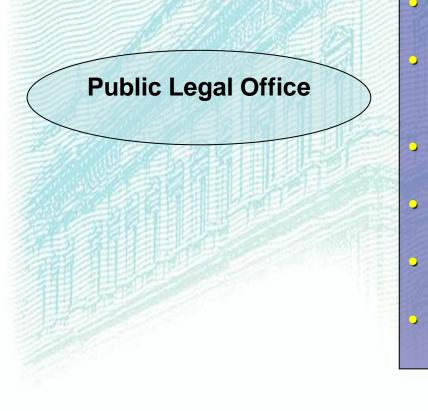
It is forbidden to *in-house lawyers* (i.e. lawyers who are bound to the client by a relationship of employment) to appear before Courts and represent their company

> The exception for public entities lawyers: enrolment in a special section of the Bar



Organisation Independency of the lawyers

Principles issued by the Rome Bar Council



Independent and autonomous
The G.C. should be a lawyer enrolled in the Special Section of the Bar
The G.C. is the co-ordinator of the Legal Office activity (*primus inter pares*)

Lawyers have no subordination to the executives

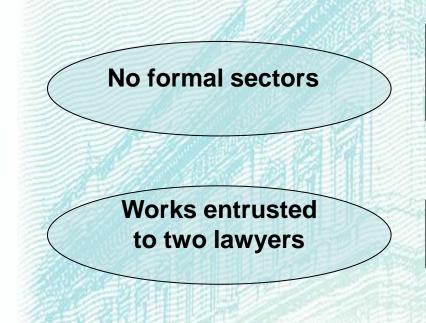
- Lawyers respond directly to the Governing Board
- Lawyers cannot be assigned to an administrative office;
 - Lawyers shall observe ethical rules issued by the Bar Council

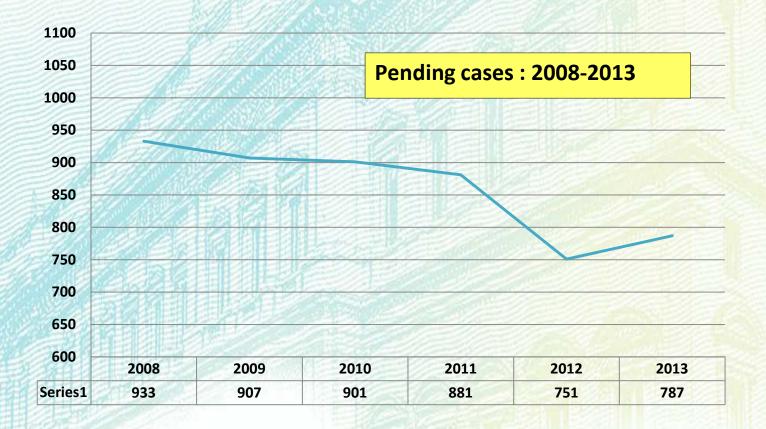
Only "de facto" specialisation Lawyers are involved both in institutional and internal matters

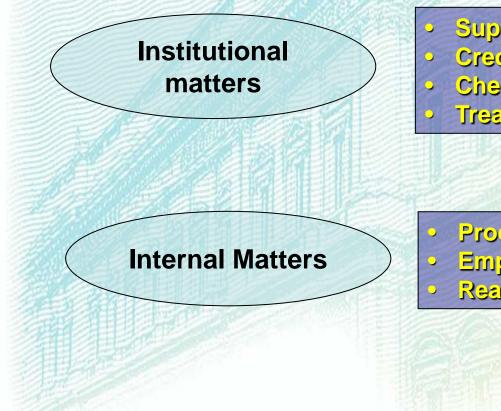


Tasks: Litigation Volume of cases handled



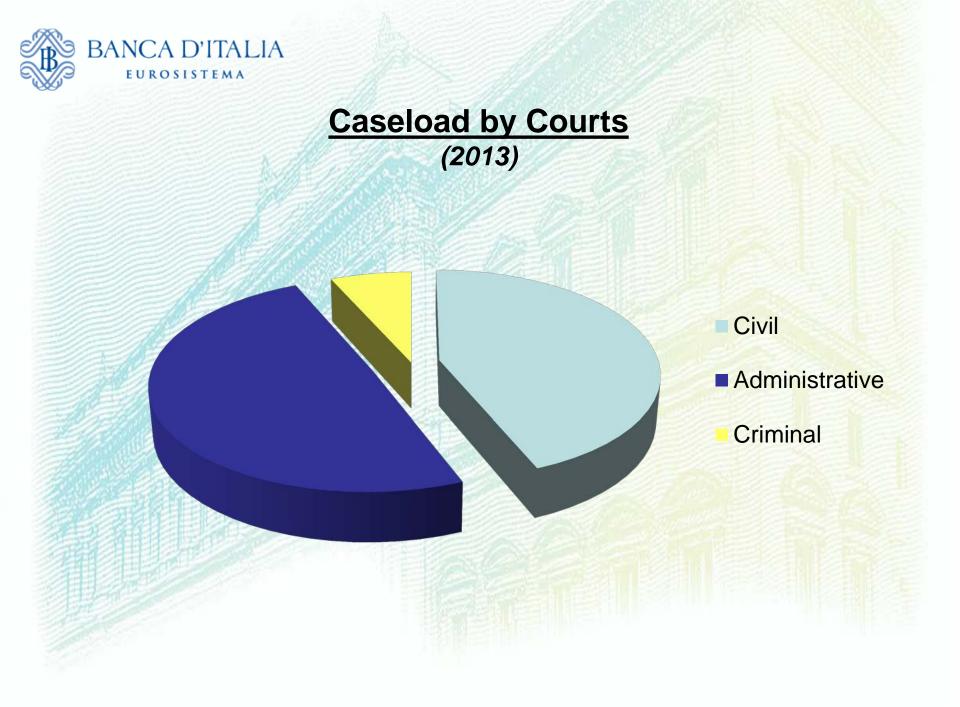


Tasks: Litigation Areas of Law



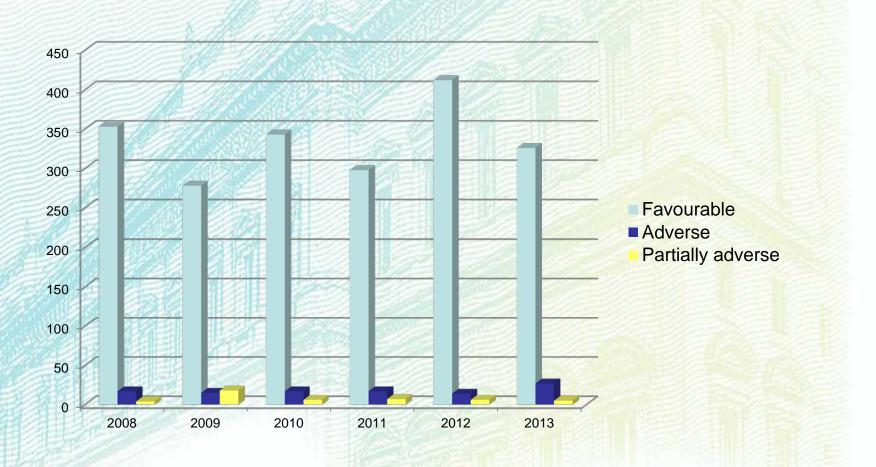

The empowerement of the attorneys

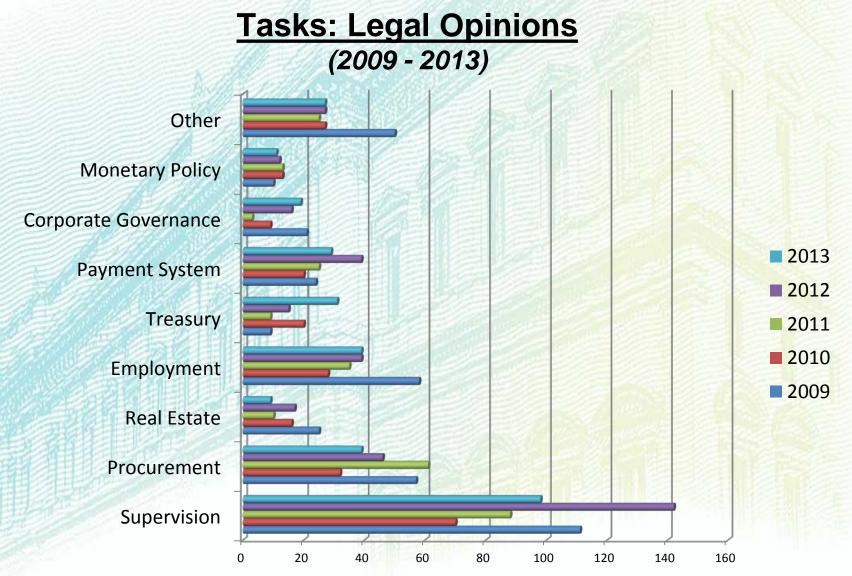
A general power of attorney exists for most lawsuits
